Non-accessible elements and content:

- Some elements of the application's interface do not have labels for the Talkback and VoiceOver screen readers, which affects the intuitive use of the application
- Some text elements in the application's interface do not adapt or respond to changes in the dynamic font size settings, which can be modified in the system settings. As a result, some content may be cut off or overlap, which limits the readability of the interface content for users. This problem affects, among other things, button labels
- Some data input fields lack suggestions for correcting detected errors. This issue occurs in the input and text area components in the address fields
- The application's interface does not adapt its elements to the dynamic screen size settings, which can be modified in the system settings. As a result, some elements may be cut off or extend beyond the device's screen, which limits the readability of the interface content for users. This problem affects the entire application
- The application does not support the system-level interface change (light/dark mode). Users are not able to use this option within the application

Fairground layout

1. East Hall (ul. Głogowska):

- accessible toilet on level 0,
- lift between levels 0 and -1 (cloakroom),
- two lifts to the mezzanine and conference rooms

6. Pavilion 1:

- accessible toilets on level 0 and +1,
- lifts between levels 0 and +1,

6. Pavilion 2:

- no accessibility facilities

2. Pavilion 3:

- two platform lifts (BISTRO and connector walkway),
- accessible toilet in the passage connecting the East Hall to Pavilion 3

3. Pavilion 3A:

- lift to the mezzanine,
- accessible toilet

4. Pavilion 11:

- lift to the mezzanine,
- two accessible toilets

5. Pavilion 12:

- accessible toilets on level 0,

In East Hall, West Hall, Pavilions 3A, 4, 5 and 11, and PCC, escalators are also available.

Level 0

- entrance to the pavilion from ground level (ramp)
- entrance to the pavilion from ground level at entrance A (sliding doors)
- passenger lift in hall A
- accessible toilet at the ramp entrance
- accessible toilets in hall A (connector walkway), showers, and behind rooms on level 01-03

Level 1

- entrance to the pavilion from ground level at entrance B
- passenger lift in hall B
- accessible toilet on the exhibition level

Level 2

- passenger lift in hall B
- accessible toilet in the foyer of the Earth Hall

The PCC Pavilion is designed in such a way that all levels can be reached from both entrance A and entrance B without using stairs. Inside, there are two passenger lifts serving all levels and upper floors from the south side.

Only the mezzanines of the Earth Hall remain difficult to access, as they are reachable only via stairs.

8. The "The Four-Pack" complex (Pavilions: 7/7A/8/8A)

- single-level layout, providing easy access to the entire area; the mezzanine in Pavilion 7 is accessible via escalator or lift.
- ramp near the regional manager's office allows access both to the office and Pavilion 7

9. Pavilion 5

- accessible toilet
- passenger lift
- two ramps from the small alley side, gates G and H

10. Pavilion 6

- accessible toilets located in sectors A, B and C
- passenger lift in sector B

11. North Hall

- accessible toilet
- external ramp from ul. Bukowska

12. WTC connector

- ramp from the WTC side
- ramp from Pavilion 5 side

13. Pavilion 5A

- single-level pavilion, providing easy access to the entire area

14. PWK underground car park

- two staircases providing access from every parking level to "PeWuKa" square
- each staircase serves two passenger lifts covering all parking levels,
- vehicle entrance/exit to the car park from ul. Głogowska

15. "PeWuKa" square

- accessible from the MTP grounds via the Fair Centre, the "Spire", Pavilions 2 and 12, and Poznań Congress Center
- accessible from ul. Głogowska via gates 9 and 10
